## Preparation:

- Developing and customizing training programs based on client needs, similar
- Confirm course details and review client policies and procedures before delivery.
- Ensuring availability of all course materials and teaching aids, including PPE
  for participants and yourself, prior to conducting every course

- Arriving prior to your course start time to ensure set up is completed in advance and you are ready to teach at start time
- Shoveling / salting walkways prior to a course being conducted at the IST office, if necessary, using the snow blower to assist in clearing snow

- Conduct safety training per lesson plans, ensuring participation and understanding in an engaging environment.
